3.6.3 Procurement Scope Statement

The procurement scope involves the purchase of a Wireless Mobile Video and Audio Recording System (WMVARS) hosted and delivered via a hybrid on-premise and cloud-based Software as a Service (SaaS) model.

The purpose of the WMVARS system is to record, view, categorize, and upload all digital evidence from both in-car vehicle and body worn camera (BWC) recording devices to a centralized cloud data repository. The contract will provide for configuration, installation, and implementation of in-vehicle cameras and support the potential future integration of BWCs.

Specifically, the contract will include:

- Configuration of direct cloud interconnection between the Contractor's SaaS cloud to CHP's enterprise network and third-party government cloud.
- Configuration of the WMVARS for System Functionality Test.
- Initial installation of a commercial-off-the-shelf (COTS) in-car recording system for CHP patrol vehicles; CHP will complete the installations statewide.
- Installation of on-premise appliances for local storage at selected CHP field offices and configuration of interface connections from those offices to the Contractor's SaaS cloud.
- Implementation and configuration of a central, cloud-based WMVARS that can be accessed from any CHP location.

The SaaS subscription will include the cost of technical support, updates, patches, version upgrades, etc. offered by the Contractor during the term of the contract.
